INVITATION FOR SUBMITTING OFFERS

Piraeus Port Authority S.A. is interested in proceeding with the procurement of spare parts and service works for the maintenance of drives' components - designed and manufactured by the company ABB - of seven (7) STS Cranes (4 SPP & 3 Panamax), in accordance with the attached technical specifications and terms of the tender, of budget 499.880,00 euros.

According to the maintenance schedule of ABB, the components of the drives should be replaced nine (9) years after the operation of the QC's.

The maintenance consists of replacements of several spare parts such fans, capacitors, auxiliary power supplies, memory backup battery etc.

Award criterion shall be the lowest total price for the procurement of spare parts & service works. Interested parties are invited to submit their offer (alternative/second offers are excluded) until **12/01/2023** at 16:00 by email to the following email address: offersubmission@olp.gr.

Offer submission will be completely electronically through email as follows:

1. Each offer should consist of two (2) individual folders: **a.** the technical offer including any participating documentation needed according to tender terms and **b.** the financial offer which should be protected with separate/different passwords. The passwords will be sent to PPA separately at each evaluation stage of the tender to a specific e-mail which will be notified by the PPA to all participants.

The offers' files **only** (not the passwords) should be sent directly to Procurement Department by the candidates at the following e-mail: offersubmission@olp.gr. before the tender's expiry deadline with the indication: Procurement of spare parts and service works for the maintenance of drives' components of seven (7) STS Cranes (4 SPP & 3 Panamax). The maximum acceptable size of each electronic offer should be 5-7 Mbytes, while the acceptable type of offers' compression is .zip (not .rar)

2. On the date and time of each evaluation stage (i.e. participating documentation – if applicable, technical evaluation, financial evaluation), the requested passwords **only** (different password for each stage) should be sent to the group email which will be notified by the PPA to all participants in due time with the indication: *"Procurement of spare parts and service works for the maintenance of drives' components of seven (7) STS Cranes (4 SPP & 3 Panamax)"*.

Within the technical offer the following must be included:

- Business profile (i.e. company profile presentation, company organization, offered products, customers, supplier network etc.),
- Recent Economic Data proving financial adequacy (i.e. tax certificate, published financial statements etc.),
- Technical Description of all offered items (characteristics, specifications, type etc.),
- Relevant compliance with quality standards must be included.
