

REPETITIVE INVITATION FOR SUBMITTING OFFERS

Piraeus Port Authority S.A. is interested in proceeding to a repetitive tender regarding a 2-year contract with a fixed cost per connection and option for annual renewal for three (3) more years after negotiations with the contractor, regarding the Corporate Mobile Telephony Program Services and Mobile Internet Connections.

Award criterion shall be the **total lowest price**, provided that all relevant requested terms and conditions are met.

Interested parties which are authorized mobile telephony providers are invited to submit their offer (alternative/second offers are excluded) until **Thursday, 23rd of May 2024 at 15:00**, by e-mail to the following email address: offersubmission@olp.gr.

Offer submission will be completely electronically through email as follows:

1. Each offer should consist of two (2) individual folders: **a.** the technical offer including any participating documentation needed according to tender terms and **b.** the financial offer which should be protected with separate/different passwords. The passwords will be sent to PPA separately at each evaluation stage of the tender to a specific e-mail which will be notified by the PPA to all participants.

The offers' files **only** (not the passwords) should be sent directly to Procurement Department by the candidates at the following e-mail: offersubmission@olp.gr. before the tender's expiry deadline with the indication: *"Provision of services regarding the Corporate mobile telephony and corporate mobile internet connections"*. The maximum acceptable size of each electronic offer should be 5-7 Mbytes, while the acceptable type of offers' compression is .zip (not .rar).

2. On the date and time of each evaluation stage (i.e. participating documentation – if applicable, technical evaluation, financial evaluation), the requested passwords **only** (different password for each stage) should be sent to the group email which will be notified by the PPA to all participants in due time with the indication: *"Provision of services regarding the Corporate mobile telephony and corporate mobile internet connections"*.

3. Within the technical offer the following must be included:

- Full business profile (i.e. company profile presentation, company organization, size & capabilities, offered products, customers, previous collaborations etc.)
- Recent Economic Data proving financial adequacy (i.e. tax certificate, published financial statements etc.),
- Description of offered services, corresponding services' data sheets, prospectus etc.
- Relevant compliance (of the Candidate) with quality standards can be included.

Candidates also have to read carefully the attached Technical Description file in which the provisions of the desired tariff plan are listed and the relevant tariff plan must be completed by the interested parties and must be included in the technical offer's file.

Any offers (with password protection) already submitted in terms of the initial tender may be maintained following relevant notice on behalf of the respective candidates or re-submitted within the abovementioned deadline.

Interested Parties may receive additional information or clarifications in relation to this Invitation for Submitting Offers, until (3) three days included, prior to the expiry of the time limit for offers submission, by submitting questions in writing to the Procurement Dpt via e-mail at procurement@olp.gr.

For the purpose of identification your written demand for payment and all other correspondence has to be presented to us in full by authenticated swift message to our swift address [.....] through the intermediary of a bank. Within the validity period of this guarantee, confirming that your original demand for payment or any other correspondence has been sent to us by registered mail or special courier and that the signatures appearing thereon are authentic and legally binding upon your company. Your written demand or other correspondence by registered mail of special courier shall be accompanied by a cover letter issued by the intermediary bank confirming that the signatures appearing on the beneficiary's attached document are authentic and legally binding upon your company. Your written demand and all other correspondence shall be issued in English language. For the avoidance of doubt, your demand for payment or any other correspondence shall be deemed to have lodged on the date on which your demand for payment or any other correspondence sent via registered mail of special courier is in our possession at our counters in [.....]

4. This letter of guarantee shall be of indefinite duration and shall remain in full force until after the fulfilment and implementation of all contractual obligations of the project and in any case shall remain in full force and effect until the earlier of: (a) the date on which all amounts available hereunder have been fully and actually drawn and paid to you; (b) upon receipt of your confirmation in writing or by authenticated SWIFT to the effect that you finally and irrevocably release us from any obligations hereunder.

Upon return, we shall be automatically released and discharged from all our liabilities under this guarantee this guarantee is returned to us from cancellation or not.

5. This guarantee is personal to you and is neither assignable nor transferable.

6. If the guarantee is forfeited, the amount of the forfeiture is subject to the applicable stamp duty.

7. This guarantee is governed by Greek law and it is subject to the exclusive jurisdiction of the courts of Piraeus, Greece.
