INVITATION FOR SUBMITTING OFFERS

Piraeus Port Authority S.A. is interested in proceeding with a **repetitive tender** regarding the procurement of CAVOTEC Cable Reel Collector Ring Packs for PPA S.A. RMGs, in accordance with the attached specifications & terms, of budget 82.000,00 euros.

Award criterion shall be the **lowest price**, provided that all relevant requested terms and conditions are met.

Interested parties are invited to submit their offer (alternative/second offers are excluded) until **Monday, 17th of June 2024 at 15:00**, by email to the following e-mail address: offersubmission@olp.gr.

Offer submission will be completely electronically through email as follows:

1. Each offer should consist of two (2) individual folders: **a.** the technical offer including any participating documentation needed according to tender terms and **b.** the financial offer which should be protected with separate/different passwords. The passwords will be sent to PPA separately at each evaluation stage of the tender to a specific e-mail which will be notified by the PPA S.A. to all participants.

The offers' files **only** (not the passwords) should be sent directly to Procurement Department by the candidates at the following e-mail: offersubmission@olp.gr. before the tender's expiry deadline with the indication: "*Procurement of CAVOTEC Cable Reel Collector Ring Packs for PPA S.A. RMGs*". The maximum acceptable size of each electronic offer should be 5-7 Mbytes, while the acceptable type of offers' compression is .zip (not .rar)

2. On the date and time of each evaluation stage (i.e. participating documentation – if applicable, technical evaluation, financial evaluation), the requested passwords **only** (different password for each stage) should be sent to the group email which will be notified by the PPA to all participants in due time with the indication: "*Procurement of CAVOTEC Cable Reel Collector Ring Packs for PPA S.A. RMGs*".

Within the technical offer the following must be included:

- Full business profile (i.e. company profile presentation, company organization, size & capabilities, offered products, customers, previous collaborations etc.)
- Recent Economic Data proving financial adequacy (i.e. tax certificate, published financial statements etc.)
- Description of the offered Cable Reel Collector Ring Packs.
- Any other available certificates proving the candidate's compliance with quality standards such as ISO 9001:2015, ISO 14001:2015 etc. (this is not a ground for disqualification).

Candidates also have to read carefully the attached Technical Specifications & Terms file, for more information regarding their technical offer's content.

Interested Parties may receive additional information or clarifications in relation to this Invitation for Submitting Offers, until ...3... days included, prior to the expiry of the time limit for offers submission, by submitting questions in writing to the Procurement Dpt via e-mail at procurement@olp.gr.
