#### **Question 25**

#### **Answer 25:**

Interested Parties shall maintain the original format of **Annex D: Financial Proposal Submission Form** as specified in the tender, without altering it, and may address optional retesting services by including a separate note e.g. (Optional Retesting Services upon PPA SA request: Cost exc. , Total Cost inc. VAT [Insert amount]).

#### **Question 26**

".....Please confirm that our understanding is correct regarding the documents required in the context of K. and L. (par. 11 of the Call of Tender), in the meaning that at the stage of the submission of proposals the Solemn Declarations alone provide sufficient evidence and that the relevant supporting documents (certificates, sworn statements etc.) shall be submitted upon request in view of the signing of the contract....."

#### **Answer 26:**

As per the requirements outlined in the Tender, the supporting documents referenced in the Solemn Declarations must be valid at the time of the proposal submission and remain valid until the signing of the contract. Interested parties are required to ensure that these documents are available and can be submitted upon request by PPA S.A. at any stage prior to the contract's signing.
