INVITATION FOR SUBMITTING OFFERS

Piraeus Port Authority S.A. is interested in proceeding with an open tender for the procurement of one (1) Multi-service Video Management Platform and one (1) HD Network Control Keyboard, budgeted 18.000,00 euros excluding Vat.

Award criterion shall be the lowest total price, provided that all technical requirements and tender terms are met.

Interested parties are invited to submit their offer (alternative/second offers are excluded) until **19.09.2025** at 16:00 by email, to the following email address: offersubmission@olp.gr.

Offer submission will be completely electronically through email as follows:

1. Each offer should consist of two (2) individual folders: **a.** the technical offer including any participating documentation needed according to tender terms and **b.** the financial offer which should be protected with separate/different passwords. The passwords will be sent to PPA separately at each evaluation stage of the tender to a specific e-mail which will be notified by the PPA to all participants.
2. The offers' files only (not the passwords) should be sent directly to Procurement Department by the candidates at the following e-mail: offersubmission@olp.gr before the tender's expiry deadline with the indication: *"Procurement of (1) Multi-service Video Management Platform and one (1) HD Network Control Keyboard "*. The maximum acceptable size of each electronic offer should be 30 Mbytes, while the acceptable type of offers' compression is .zip (not .rar).
3. On the date and time of each evaluation stage (technical evaluation, financial evaluation), the requested passwords only (different password for each stage) should be sent to the group email which will be notified by the PPA to all participants in due time with the indication: *"Procurement of (1) Multi-service Video Management Platform and one (1) HD Network Control Keyboard "*.

Within the technical offer the following must be included:

- Business profile (i.e. company profile presentation, company organization, offered products, customers, supplier network etc.),
- Recent Economic Data Recent Economic Data proving financial adequacy (i.e. tax certificate, published financial statements etc.),
- Technical Description of the offered items according to the tender requirements with clear references to the delivery time and the warranty period (pis see the attached Technical Description)
- All offered devices and equipment must be accompanied by their appropriate certification and manuals (pis see the attached Technical Description)
- A signed solemn declaration by the bidder, signed by a legal representative (accompanied by the current representation certificate), stating that the offer complies with the terms and conditions of the present tender.
