2ND REPETITIVE INVITATION FOR SUBMITTING OFFERS
“Repair of Travelling System of 15tn Crane at Floating Dock Piraeus III”

1. Introduction

Piraeus Port Authority S.A. invites interested parties to submit their offers for the “Repair of Travelling System of 15tn Crane at Floating Dock Piraeus III”, budgeted at 15.000 euros excl. VAT.

2. Scope of Work

The objective of this project is the provision of repair services regarding the boogie travelling system of the 15tn crane at FD Piraeus III.

3. Award Criterion

The award criterion for this procedure is the **lowest price for the total of works** herein described.

No contract is required for the specific case.

4. Offer Submission

Interested parties are invited to submit their offer until **Tuesday 21 October 2025, at 16:00.**

The Submission Folder will contain two separate sealed (sub)folders, namely:

- “Technical Offer” containing documentation according to Paragraph 5 “Technical Offer” and Annex I “Technical Specifications”.
- “Financial Offer” containing documentation according to Paragraph 6s “Financial Offer” and Annex II “Financial Offer Form”.

One of the following methods must be chosen:

- B. *Digital Folder*, by submitting a .zip folder marked as **[Company Name]_Repair of Travelling System of 15tn Crane at Floating Dock Piraeus III**. The two (sub)folders mentioned above must be each protected by a dedicated password, which will be requested during the Evaluation procedure by PPA’s relevant Evaluating body. The folder size must not exceed **30MB**.

Interested Parties may receive additional information or clarifications relating to the procedure *until 3 days before the submission deadline*. All relevant questions to the above shall be directed to Procurement Department via email **exclusively** to the following email address: procurement@olp.gr.

5. Technical offer

Within the technical offer, the following must be included:

- Technical Description of the offered works according to the tender requirements with clear references to the offered items etc. (for more details, you may refer to **Annex I**)
- Any other available certificates proving the candidate’s compliance with quality standards such as ISO 9001:2015, ISO 14001:2015 etc. (*this is not a ground for disqualification*).

- Detailed Certificate of Representation from Hellenic Business Registry (GEMI)
- Tax clearance certificate valid and in force
- Insurance clearance certificate valid and in force
- A Solemn Declaration from the Tenderer's Legal Representative according to Annex III
- A Solemn Declaration from the Tenderer's Legal Representative according to Annex IV.

6. Financial offer

The Financial Offer Folder will contain the Financial Offer form as per **Annex II** filled and signed.

No alternative offers will be considered.

7. Duration of the works

The contractor shall commence work within two (2) days from the award notice, and the project has to be fully completed within seven (7) calendar days from the commencement of works.

8. Payment Terms

Within two (2) months upon invoicing and following acceptance of the works by competent PPA S.A. acceptance body. Required Documentation consists of:

- Invoice to PPA SA
- PPA certificate of acceptance

9. Parts Repair & Spare Parts

Prior to the commencement of the repair works, a PPA committee (established by Engineering department's DCEO) will perform an onsite inspection at the contractor's workshop in order to inspect the internal damage of the parts and identify & finally decide which parts need to be replaced. The outcome of the inspection (report) will be attached to the respective Payment Approval and will constitute a necessary provision for the Contractor's invoice payment, together with the final certificate of acceptance.

10. Other Terms and Conditions

It is obligatory to clearly state the proposed duration of the requested repair services.

Submissions in both Greek and English language are accepted for this Invitation.

If, for any reason, the submission of offers does not take place on the aforementioned date, or if it does take place but no bids are submitted, it will be held on a new date, which will be communicated to the participants. The same procedure may be repeated a second time.

Each Candidate may submit only one offer.

The prices submitted must be in full compliance with the terms of the Invitation, shall be fixed and shall not be subject to increases for any reason during the provision of the services laid out herein and any extensions thereof.

The decision to select the Contractor, as well as other decisions related to the procedure, will be made by the competent Management body of PPA SA. Based on the above decision, the PPA's Procurement Department will notify the participants of the outcome of the tender. The decisions of PPA S.A. are final and no complaints or objections against them will be taken into consideration by PPA S.A.

The body of PPA SA responsible for the Contractor selection process is not bound by the final award of the supply and is entitled to award it or not, to postpone it, repeat or cancel the Contractor selection process in whole or in part at any stage with a reasoned decision, without any obligation to pay remuneration or compensation to the Candidates. If the procedure is postponed, repeated, or canceled, any Financial Offers submitted will not be opened.

Participation in the procedure is at the Candidate's own risk, who is not entitled to any compensation for expenses related to their participation in the procedure and the preparation and submission of the Offer.

PPA SA declares that it has fully complied with the requirements of the new General Data Protection Regulation and will comply with the relevant provisions throughout the tender process.

PPA SA is neither a public body nor a public contracting authority, and the provisions of Law 4412/2016 on public contracts do not apply to the award of its contracts. Therefore, PPA SA has no specific legal obligation to disclose internal tender documents to participants (and in particular to those who were not selected as contractors).

ANNEX I Technical Specifications

The objective of this project is to ensure the boogie travelling system of the 15tn crane is fully operational by engaging a qualified contractor to provide the following repair services:

- Dismantle and remove the defective boogie travelling system.
- Transportation of the system parts to the contractor's workshop.
- Perform necessary replacement of damaged/worn components, and servicing (optical inspection, cleaning, measurements etc.)
- Reassemble, lubricate & paint touch up (if deemed necessary and agreed with PPA S.A.) of the assembly, transportation back to PPA SA site.
- Reinstall the travelling system onto the crane.
- Conduct operational testing to verify full performance and safety compliance.

Additional Costs: All the necessary materials / spare parts will be provided by PPA S.A. or by the Contractor, following the system disassembly by the Contractor & the inspection of the parts by PPA S.A., the submission of an extra relevant offer by the Contractor and the offer's acceptance by PPA S.A. The extra cost of the materials/parts to be used/replaced is not included in the cost of the above-mentioned described works, as it is not known prior to the disassembly.

Lifting Equipment, Power supply: PPA SA adjacent Jib Crane (operated by PPA SA) may be provided to the awarded contractor if available and in agreement with Ship Repair Dpt. PPA SA will provide power supply to the Contractor. No other lifting equipment will be provided by PPA.

Site Visit and Requests for Clarifications: All interested parties are advised to visit PPA S.A. premises at Perama (Floating Dock No III) before submitting their quotations. During the visit, they are expected to assess the damage and the site conditions, and ensure a full understanding of the project's technical requirements. This will help safeguarding accurate planning and execution. Any request for clarification or/and for further technical documentation (if available) can also be addressed during the visit.
