Subject: Clarifications to the interested parties regarding the Call of Tender for the procurement of one Floating Dock .

Question 1: Would you please explain to us that who(or which department)should give the following certificates?

The candidate should provide the following relevant certificates or certified copies of each according to applicable law:

- (a) Certificate of their country of establishment stating that the participant is not bankrupt or is the subject of insolvency or winding up proceedings.
- (b) Certificate of their country of establishment stating that the participant is not under mandatory administration.
- (c) Certificate of their country of establishment stating that the participant is not under liquidation or administered by a Liquidator
- (d) Certified copies of current Tax and Social Insurance Compliance Certificate, or equal evidence in accordance with the law of place of the Candidate's establishment.

Answer 1: The above mentioned certificates can be collected from the relevant Registries of the Participant's country of establishment, i.e. Court Registries, Tax Registries, Social Security Registries or other relevant Registry according to the country of establishment.

Question 2: Regarding the coating of the floating dock we need more details about the requirements or regulations for the coating and any necessary certificates for the coating?

Answer 2: The coating should be according to applicable environmental standards, approved by the Classification Society of their country of establishment. The specifications of the coating and the applicable standards must be stated in the offer and will be evaluated by PPA S.A.

Question 3: Regarding about the sentence "The time limit for the submission of offers is 8th of May 2017 until 14:00 Greece time. "Means by the time 8th of May 2017 until 14:00 Greece time, PPA side should receive the offers or COSCOSH should post out ?

Answer 3: According to the tender:

"The time limit for the submission of offers is 8th of May 2017 until 14:00 Greece time."

The Offers shall be submitted to PPA's Central Protocol only in English language in person by the Candidate's Authorized Representative.

Alternatively, the Offers may also be sent to PPA's Central Protocol by registered post upon proof of receipt dated no later than 8th of May 2017."

According to the above, offers should be received to PPA's Central Protocol office by May 8th, 2017, 14:00 Local Time (Greece)

Question 4: Could you pls provide an extension on the time limit

Answer 4: Extension cannot be granted.
