Subject: **Clarifications to the interested parties and extension granted** regarding the Call for Tenders for the procurement of two (2) Event Hall and New meeting room Video Wall projects **PART II**

Interested parties are kindly requested to refer to all clarifications published provided by PPA, regarding the questions received until 21st February 2020, in relation to the "Call for Tenders for the procurement of two (2) Event Hall and New meeting room Video Wall projects".

The said replies constitute an integral part of the Call.

Question 1:

We have the following questions/requests regarding the procurement & installation of 2 video wall systems:

- We cannot find any reference on delivery dates. Is there any specific demand or preference on delivery time for the project?
- Due to a small delay on obtaining some of the prequalification documents we need an extension of the tender deadline or for the pending documents. Is this possible?
- On B.1.2 Financial and economic standing criteria the offerer is demanded to have an average annual turnover over the last 2 years of over 1.000.000,00€.
Our turnover on the last 2 years is "....." which is very close to your average demand. Is there a possibility due to so close numbers and considering our already established and successful installations on PPA to qualify our offer?

Answer 1:

- i. No specific delivery day is mentioned, but delivery date must be as soon as possible and will be evaluated.
- ii. **We accept to extend the tender deadline for the offers' submission for two weeks, until 10th of March 2020.**
- iii. This is eligible criterion cannot be changed.

Table "1) Event Hall Video Wall", specification "Pixel Pitch $\leq 2.5\text{mm}$ " and Table "2) Meeting Room Video Wall", specification "Type: LCD Screen Bezel to bezel $\leq 1.7\text{mm}$ ":

Please confirm that products with relative negligible deviations of **0.1mm** or less ($\leq 0.1\text{mm}$) on the specific values requested will be also accepted, in order for OLP to be able to evaluate competitive solutions from more than one manufacturer.

Question 5:

In reference to the Call of Tender - For the procurement of 2 video wall systems for the needs of PPA S.A, we would appreciate your clarification to the following:

- Regarding the technical specifications, we noticed that it is required for the meeting Room Video Wall, LCD Screen Bezel to Bezel $\leq 1.7\text{mm}$.
 - o Please inform us whether for the specific characteristic of Bezel to Bezel (in the LCD Screens) it is acceptable to offer $\leq 1.8\text{mm}$ (the difference in the bezel width of 0.1 mm is insignificant as it is less than the thickness of a human strand of hair)
 - o Also please let us know whether an LCD Screen with size greater than 46" with Bezel to Bezel $\leq 1.8\text{mm}$ will be positively evaluated?

Answer 5:

We accept only what is compliant to the technical specifications of the tender.

Question 6:

- "....." want to bid this videowall tender. But we are still preparing some related material.

Can we postpone this tender for 2 weeks more, until 10th Mar. 2020?

- Another requirement regarding Bank Guarantees, can you remove this from the tender?

Question 7:

In reference to the Call of Tender - For the procurement of 2 video wall systems for the needs of PPA S.A, we would appreciate further clarifications on the following:

- Regarding the Meeting Room Video Wall and in particular regarding the required "Display stand by hydraulic support", could you please clarify which are the specific technical characteristics of the hydraulic support (i.e. dimensions, max height, etc), a relative hydraulic stand example would be very helpful.
- Would a wall pull-out monitor stand satisfy the tender requirements?
- Also could you please provide us with some additional information regarding the specific installation site characteristics (i.e. the place the video wall will be installed- will it need a floor stand or wall stand? etc).

1. The requirement is related to a mechanism which will be used to help us easily removing a monitor
2. Yes
3. A floor stand is needed
