1. CONTRACTING AUTHORITY – SCOPE OF TENDER

1.1 The Contracting Authority

The Contracting Authority is PPA.

1.2 Scope of Tender

The scope of the tender shall be the *‘Procurement of four (4) electric towing tractors for cruise & Ferry Department of PPA’* with a delivery time of **six (6) months** from contract date, **in terms of Delivery Duty Paid (DDP)**, ready to operate at PPA S.A.

Note that for the successful completion of the procurement, the selected counter party shall undertake **at no extra cost** for PPA:

- The tractors’ a. transportation and fees, b. custom clearance process and fees and c. homologation procedure and related fees.
- The process of obtaining the relevant type approval and the relevant license plates for the tractors in Greece, according to the applicable and latest Greek and EU legislation, as in force, by providing all the necessary documents to PPA and the competent Greek authorities and proceeding with any necessary act for this purpose.
- The on-site technical and operational training at PPA premises for the provided equipment.
- The delivery of spare parts and special tools as requested within this call.

2. TERMS AND CONDITIONS

2.1 Provisions of clarifications

Interested parties may receive relevant additional information or clarifications, until three (3) days included, prior to the expiry of the time limit for offers' submission, by submitting questions in writing to the Procurement Dpt to the following email address: procurement@olp.gr .

Candidates are not allowed to refer to verbal responses or clarifications by PPA.

2.2 Submission of offers

Interested parties are invited to submit their offer (alternative/second offers are excluded) **until 22 August 2022 at 16:00** by email to the following email address: offersubmission@olp.gr .

Offer submission will be completely electronically through email as follows:

1. Each offer should consist of two (2) individual folders: a. the participation documentation and technical offer folder according to tender terms and b. the financial offer which should be protected with separate/different passwords.
2. Both aforementioned folders should be protected with separate/different passwords. The passwords will be sent to PPA separately at each evaluation stage of the tender to a specific e-mail which will be notified by the PPA to all participants.
3. The offers' files only (**not the passwords**) should be sent directly to Procurement Department by the candidates at the following e-mail: offersubmission@olp.gr before the tender's expiry deadline with the indication: *"Offer for the Procurement of four (4) electric towing tractors for cruise & Ferry Department of PPA"*. The maximum acceptable size of each electronic offer should be 5-7 Mbytes, while the acceptable type of offers' compression is .zip (not .rar).
4. On the date and time of each evaluation stage (i.e. a. participating documentation –, technical evaluation, b. financial evaluation), the requested passwords only (different password for each stage) should be sent to the group email which will be notified by the PPA to all participants in due time with the indication: *"Offer for the Procurement four (4) electric towing tractors for cruise & Ferry Department of PPA"*.

Within the Participation Documentation - Technical Offer folder the following must be included:

- The Participation Letter of Guarantee or confirmation of submission of payment as mentioned within par 2.5 hereof.
- Business profile (i.e. company profile presentation, company organization, offered products, customers, supplier network etc.),
- Recent Economic Data proving financial adequacy (i.e. tax certificate, published financial statements etc.),
- Technical Description of all offered items including warranty and delivery time details in line with the structure and the technical requirements mentioned within Annex A of the present Invitation.
- Relevant compliance with quality standards must be included.

IMPORTANT NOTES:

1. The Technical Proposal must not include any financial information.
2. Copy and paste of the minimum requirements of the technical specifications of Annex B shall not be considered as sufficient proof of the Candidates understanding of PPA's specific technical requirements for the equipment

2.3 Validity of offers

- Offers shall bind the Candidates for at least one (1) month from the submission deadline date. Any offer which sets forth a term of validity less than the above mentioned shall be rejected.
- Participants are advised that they may be requested to extend the validity of their proposals for additional period until the contract award is completed. It is at PPA's sole discretion to cancel the whole bidding process without compensation to the bidders.





2.4 Financial Specifications

- Participants are requested to submit a financial offer according to the requirements of Annex B.
- The following costs for the equipment will be fully borne by the awarded Supplier:
 - i. All the test and certificate costs, including the costs of issuance of type-approvals, registration plates, license registries and, in general, for the fulfilment of any other relevant legal requirements related to the use and function of the equipment according to Greek Law.
 - i. All documentation, manuals and specific tools and instruments as stated in this Tender document.
 - ii. Costs of transportation, related insurance and customs clearance.

- Negotiable Indicative Payment Terms:
 - 30% payment in advanced within ten days after contract signature and with the obligation to submit an equal amount letter of advance payment guarantee as per the form of Annex C.
 - 60% payment upon equipment arrival.
 - 10% payment upon approved by PPA SA final acceptance of the equipment.

2.5 Letters of Guarantee

- The guarantees required (participation/advanced payment/good performance) for this tender procedure may be in one of the following forms:
 - Letters of Guarantee in accordance with Annexes C or D or E
 - Deposit to PPA (one of the following PPA bank accounts) as a guarantee of the respective amount of money.

- A counterbalance letter of guarantee with the participation of a second bank in the basic tripartite relationship of the letter of guarantee between the issuing bank and the recipient of the guarantee.
- The bonds shall be addressed to PPA, and in the event of a Joint Venture or Grouping must be common to all members hereof.
- Errors or omissions in the title of the procurement or the person in whose favour the bond is provided will not lead to disqualification provided no confusion is caused.
- The **Tender Participation Bond** will amount to five thousand euros (5.000,00 €) with duration one (1) month longer than the validity of the offer according to **Annex C**. The Tender Participation Bond shall be seized by PPA if, while it is in effect, (a) the tenderer withdraws its tender or (b) the

interim Contractor does not submit the award documentation in good time or does not come forward in good time to sign the contract or (c) the above persons provide false evidence or information relating to the grounds of disqualification. The Participation Bond may be returned to unsuccessful Candidates within fifteen (15) working days from the completion of the Tender (contract signature is considered as tender completion) and to the successful Candidate upon signature of the agreement.

- Regarding the 30% advance payment on the total contractual value, the Contractor will submit to PPA an **Advance Payment Letter of Guarantee** of equal amount according to Annex D.
- The winning bidder will sign a contract. An open-ended **Good Performance Guarantee** of the contract terms upon signing the Contract is required. The Good Performance Guarantee will be issued in accordance with Annex E by a financial institution lawfully operating in Greece or other country acceptable by PPA in favour of PPA for an amount equal to 5% of the total amount of the contract, not including VAT. The good performance guarantee will be valid until the end of the warranty period of the tractors. This performance guarantee will ensure the proper, flawless and timely implementation of the contract terms and timely and proper performance of its obligations to the PPA.

3. EVALUATION PROCESS – AWARD CRITERION

The evaluation committee appointed by PPA shall evaluate the proposals on the basis of their responsiveness to the requirements set by this Call, applying the evaluation criteria as follows:

Evaluation of Technical Proposal/ Technical Score:

- **Technical Score (St)= maximum total points 100**, according to “Minimum Technical Requirements – Scoring Criteria” Table values of ANNEX A. The formula for determining **the Financial Score (Sf)** shall apply as follows:

$$\text{Sf} = 100 \times \text{FM} / \text{F}$$

Where:

- Sf is the financial score;
- FM is the lowest priced Financial Proposal and
- F is the price of the proposal under consideration.

Proposals will be ranked according to their **combined technical (St) and financial (Sf) scores** using the weights:

Where:

- T = the weight of 60% given to the Technical Score;
- P = the weight of 40% given to the Financial Score; and
- T + P = 1.

The combined technical and financial score, S, is calculated as follows: -

$$\text{S} = \text{St} \times \text{T} \% + \text{Sf} \times \text{P} \%$$

The Candidate achieving the highest combined technical and financial score (S) will be ranked first and will be the temporary winning bidder. In the event of an absolute tie the Candidate with the highest Sf score will be ranked first and will be the temporary winning bidder.

ANNEX A: TECHNICAL DESCRIPTION

General Requirement

The Electric Towing Tractors will be 4-wheel type, man on board, rear-wheel drive, suitable to tow loads of at least 15.000 kg on level ground and should be capable to handle luggage trailers with great versatility and maneuverability for optimum space utilization.

The Electric Towing Tractors should be reliable and also ideal for all intense duties - both indoors and outdoors, further should be built, on a tested platform with high stability and durability, only with branded quality components in order for the operators to drive consistently and safely.

The Electric Towing Tractors should be equipped with, hydraulic power steering, front & rear suspension, pneumatic tires on heavy-duty wheel rims, proper braking system acting on front and rear axles/wheels, automatic parking brake, towing hitches at rear and front.

The machine must be equipped with a quick and easy troubleshooting system for operators, so the troubleshooting time to be reduced to minimum and high availability to be maintained. The machine must comply with the most recent operator health and safety guidelines and must be equipped with all safety features that will make the operation as comfortable and safe as possible.

Every Electric Towing Tractor will have his own battery and his own battery charger, accompanied with all proper equipment for charging.

Additionally, it is clarified that an extra charger (spare charger) and an extra battery (spare battery) should be delivered, accompanied with all proper equipment for charging, that will be used as spare for all towing tractors in case is needed for extraordinary reason.

The whole construction of the towing tractor should be extremely reliable, easy to service with minimum service intervals and all parts should have easy access for fast and effective maintenance. Every towing tractor should be accompanied with operating and maintenance manuals as well as spare parts list in English language (the operators manuals should be translated also to Greek language).

Last but not least, the training schedule for operators and technicians should be proposed from the candidates within their offer.

Operating Environment

The Electric Towing Tractors should be designed to work under ambient temperature from -10 to 50°C. They will be suitable for working under any normal, rain and night operation, under dusty conditions, such as dust, grind material, salty air, fog and air with acid/alkaline particles.

Technical features

The Electric Towing Tractors will be 4-wheel type, man on board, rear-wheel drive, suitable to tow loads of at least 15.000 kg on level ground and should be capable to handle luggage trailers.

The frame should be steel construction welded with high stability and durability (preferably zinc dipped), only with branded quality components in order for the operators to drive consistently and safely, ideal for all industrial duties both indoors and outdoors, even on long distances.

The steering should be hydraulic power steering type and the steering column should be adjustable type (height and tilt).

The Electric Towing Tractors will have full suspension at front and rear axles with pneumatic tires and heavy-duty wheel rims. The braking system will act on both front and rear axles, the parking brake should be operating automatically (engage and release).

The electrical drive should be AC motors on wheel gears type and the motion control AC inverter with energy recovery system, acting during deceleration and braking. The battery and the battery plugs should be according to the applicable DIN standards for on-board electric systems.

The machine will be designed for maximum continuous working time with one battery pack and one charge (the time of fully recharging the batteries pack must be mentioned in the offer in order to be evaluated).

It is clarified that the time of continuous working time with one battery pack and one charge should be stated by the candidates at their technical offer in order to be evaluated. The calculations for continuous working time will be based on following data:

- Towing load of 8 tons
- Speed of 10 km/h
- On dry level surface

Important Note:

The Candidate should describe the electric towing tractor that offers by submitting all relevant technical details and data sheets, in order to be evaluated.

Detailed data and diagrams for Drawbar pull (N)/Gradient (%), Drawbar pull (N)/Speed (Km/h), Drawbar pull (N)/Ramp Length (m) should be submitted within the technical offer.

Cabin

The machine must be equipped with, a well-designed cabin, with side doors, which will offer great visibility (forwards/backwards), a fully ergonomically adjustable operators' seat, steering column with height and tilt adjustments, proper control levers in order for the operators to work in a comfortable and safe environment by having the full control of the machine.

Driver's cabin will have at least the following:

- Ergonomically and multi-adjustable seat with belt (proper for up to 150kg weight of operator) and operator presence system
- Two hinged or sliding side doors, tinted and tempered windshields, wiper, sun shield, inside rear-view mirror and outside rear-view mirrors on the left and right-hand side
- Hydraulic power steering with height and tilt adjustable steering column
- Steering wheel with spinner
- User-friendly and ergonomic dashboards with battery charge indicator deep discharge alarm of protection, fault detection, speedometer and hour meter
- Control switches and levers with symbols
- Complete automotive road lighting and signal system (head lights, tail lights, direction indicators, stop lights, horn, etc.)
- Auxiliary loading area behind the driver's seat
- All the lights must be LED technology.

Documentation, certification and spare parts

The Electric Towing Tractors should bear the CE marking, accompanied by the EC declaration of conformity.

The manufacturer should have a valid ISO 9001 certificate for manufacture of the same kind of towing tractors at the same manufacture site as those offered.

Every towing tractor should be accompanied with operating and maintenance manuals as well as spare parts list in English language (the operators manuals should be translated also to Greek language).

Every Electric Towing Tractor will have his own battery and his own battery charger, accompanied with all proper equipment for charging.

One spare battery pack plus the relevant charger will be delivered for all towing tractors, for spare use in extraordinary case.

One spare front wheel and tyre and one spare rear wheel and tire will be delivered for each towing tractor.

6. No approval, act or consent on the part of any of the Participants, the applicant(s) hereof or any third party shall be required for payment of any amounts hereunder. In addition, no objection or disagreement of any of the foregoing persons or their eventual recourse to courts of any jurisdiction or arbitral tribunals seeking non-forfeiture of this letter of guarantee shall be taken into consideration.
