**USAGE AND RENTAL RIGHTS OF MECHANIC EQUIPMENT AND CARGO  
HANDLING TOOLS**

## **A'. SHORE CRANES (MOBILE - ELECTRIC):**

### **1. USAGE RIGHTS:**

- a) Cranes with lifting capacity up to 8 tons per hour 46, 8 euro  
b) Cranes with lifting capacity over 8 tons “ “ 67, 6 “

### **2. RENTAL RIGHTS:**

The corresponding per-hour usage rights are paid.

- Minimum usage or rental time is 4 hours.

In case of usage or rental of a crane for only 1 movement whose duration is not over 30 minutes, the charge is the normal rate per hour

## **B'. GANTRY CRANE :**

### **1. USAGE RIGHTS:**

For the use or rental of the Gantry Crane for the loading/discharge of cargo of the 1st Tariff of PPA SA the provisions on the corresponding rights for cranes with lifting capacity over 8 tons apply accordingly.

## **C'. FORKLIFTS:**

### **1. USAGE RIGHTS :**

For the usage, following request application, of a forklift in the hold in order to facilitate the cargo handling works of all kind, except for palletized , the provisions for the rent of forklifts are applicable

### **2. RENTAL RIGHTS:**

- a) Up to 2 tons per hour 41, 6 euro  
b) Over 2 tons « « 56 «  
c) Exceptionally, it is permitted to make available the machinery out of the port area for Military Services by paying an undividable daily rent of euro 156.

## **D' LOADING/DISCHARGE TOOLS AND SLING EQUIPMENT:**

In case of pallet boxes' loss, damage or no return, within sixty (60) days, the charge is the normal rate plus compensation 46.8 euros per piece.

#### **O'. RENTAL OF CONVEYOR BELTS:**

For the rental of conveyor belts, at the request of and on behalf of shipping agents or vessel suppliers, to facilitate the (up)loading works, the following must be paid:

a) For the first 3 hours undivided	28,318 euro.
b) Every other hour after 3 hours	9,669 euro.

#### **P'. BERTHED SHIPS TELEPHONE LINE PROVISION:**

a) For every phone connection	104 euro.
b) For every phone disconnection	104 euro.
c) For each telephone unit (regardless of their number) recorded by the tax indicator that connects the main telephone device, the respective corresponding invoice of OTE.	

#### **Q'. RENTAL OF ANTIFREEZE UNIFORMS:**

a) For every uniform, per 15 days undivided	11,106 euro.
b) In case of uniform loss or damage, the charge is the price of the uniform:	216,032euro.

The above mentioned charge is the normal rate plus 25% of normal rates for recovery & overestimation cost of the uniforms.

#### **R'. RENTAL OF MERCHANDISE COUNTERS:**

a) For each counter, per 15 days undivided	5,368 euro.
b) In case of loss or destruction of the counters, the charge is the counter's cost:	792,014 euro.

The aforementioned charge is the normal rate plus 25% of normal rates for recovery & overestimation cost of the counters.

**U'. ELECTRICITY SUPPLY:**

a) For the supply of electricity of third-party consumers	Distribution according to the cost of provision by the PPA provider based on the most recent quarterly bill plus a surcharge of 0.05cent plus VAT.

The distribution of electricity costs among third party consumers is based on the square meters of conceded space or on the actual recorded consumption where meters exist.

The above charge is borne by third parties (buildings, public services, etc.) who are electrified by medium voltage supplies or by independent low voltage supplies, even if the supply is used for a period of less than a month.

b) electric supply to ships that are at the PSRZ (Perama Ship Repair Zone)	Standard charge per day and taking	41,6 euro.

**V' – TRANSITS**

1. The private ship-to-shore cranes or other similar lifting machines are charged with daily indivisible right of port usage and works execution euro (€) 15,00.
2. The private floating cranes are charged with daily undividable right of port usage and works execution euro (€) 70,00.
3. The compressors, generating sets, other private land machines are charged with daily undividable right of port usage euro (€) 3, 00.

**W' – METAL FENCING**

Provision of metal fencing to a conceded area close to vessel: charge with 5 euros/metre/day. The rest of the charges are based on Tariff and Regulation for the provision of staff and material for fencing installation according to vessel's orders.

**NOTES:**

1. Minimum usage or rental rights time is 4 hours. The first 15 minutes of usage or renting after the first 4 hours, are free of charge. The usage or renting rights time that exceeds 15 minutes after the first 4 hours, it is calculated as a whole hour.
2. In case of renting mechanic equipment on Sundays or in Holidays, the charge is normal rates plus 20% of normal rates.
3. In case of night overtime work, after 22:00, the charges are normal rates plus 15% of

- normal rates for working days , normal rates plus 35% of normal rates for Holidays .
4. The working time of the machine includes the waiting time of the machine.
  5. In case of revoking the rental application of any mechanic equipment or tool, the charge is the normal rate which cannot be less than the charge that the regulation provides for minimum usage or rental time.
  6. In case of PPA's inability to lift certain loads because of their volume or their weight, or the PPA cranes are damaged, the (Up)loading manager is authorized to approve the use of private floating crane (crane vessel).The charge is 1,104 €/ton.
  7. In case of equipment disposal out of port area, the charge is normal rates plus 100% of normal rates.
  8. a. The provision of PPA SA ladders requires application submission by the interested parties to the relevant service of PPA SA as model 1 and at the same time payment of the rental rights related to the requested time.  
In any case, an amount of 156 euro for each ladder to cover any damage or damage that will be incurred at the time of its use or to cover the corresponding rights in the event of an unauthorized use beyond the time requested is paid in advance as warranty. .  
b. Subject to the requirements of the previous paragraph, the competent department of the PPA District Department concerned with the relevant Service Note, as Model 2, orders the availability of the ladder.  
In the Service Note, which is signed by the person concerned, the status of the ladder is mentioned upon ladder's receipt. Upon receipt by the ship's representative and during the rental period, PPA SA shall bear no civil or criminal liability for damage to the ladder or third  
c. After the delivery of the ladder to the competent service of PPA SA, the above amount is reimbursed to the beneficiary unless there is damage or overtime usage when the liquidation is executed and the relevant amount is withheld (Decision.64 / 20-3-2006 B.o.D/PPA S.A).
  9. The use / leasing of Straddle carrier, heavy forklift "Wolf" 15ton and 33ton forklifts is charged with the corresponding charge of a crane of a lifting capacity of more than 8 tons. The use / rental of a Truck (nail) is charged with the corresponding forklift charge of more than 2 tons.
  10. The seal for containers is charged with € 10 per unit.
