INVITATION FOR SUBMITTING OFFERS

Piraeus Port Authority S.A. is interested in proceeding with the procurement of batteries for all the vehicles and machinery covering six-month needs for A7, A8 & A9 workshops of Engineering Dep, budgeted 15.681,72 euros.

Award criterion shall be the lowest price per item.

Interested parties are invited to submit their offer (alternative/second offers are excluded) until **31.03.2025 at 15:00** by email to the following email address: offerssubmission@olp.gr.

Offer submission will be completely electronically through email as follows:

1. Each offer should consist of two (2) individual folders: **a.** the technical offer including any participating documentation required according to tender terms and **b.** the financial offer which should be protected with separate/different passwords.
2. Both aforementioned folders should be protected with separate/different passwords. The passwords will be sent to PPA separately at each evaluation stage of the tender to a specific e-mail which will be notified by the PPA to all participants.
3. The offers' files **only** (not the passwords) should be sent directly to Procurement Department by the candidates at the following e-mail: offerssubmission@olp.gr before the tender's expiry deadline with the indication: *"Offer for the procurement of batteries for all the vehicles and machinery covering six-month needs for A7, A8 & A9 workshops of Engineering Dep"*. The maximum acceptable size of each electronic offer should be 5-7 Mbytes, while the acceptable type of offers' compression is .zip (not .rar).
4. On the date and time of each evaluation stage (i.e. participating documentation – if applicable, technical evaluation, financial evaluation), the requested passwords **only** (different password for each stage) should be sent to the group email which will be notified by the PPA to all participants in due time with the indication: *"Offer for the procurement of batteries for all the vehicles and machinery covering six-month needs for A7, A8 & A9 workshops of Engineering Dep"*.

Within the technical offer the following must be included:

- Business profile (i.e. company profile presentation, company organization, offered products, customers, supplier network etc.),
- Recent Economic Data Recent Economic Data proving financial adequacy (i.e. tax certificate, published financial statements etc.),
- Technical Description of the offered items according to the tender requirements with clear references to the offered warranty period and delivery time (pls see the attached Technical Description)
- Any available certificates proving the candidate's compliance with quality standards such as ISO 9001:2015, ISO 14001:2015 etc. (this is not a ground for disqualification)
- A signed solemn declaration by the bidder, signed by a legal representative (accompanied by the current representation certificate), stating that the offer complies with the terms and conditions of the present tender.

The offers shall bind the candidates for at least two (2) calendar months from the submission deadline date.

Interested Parties may receive additional information or clarifications in relation to this Invitation for Submitting Offers, until three (3) days included, prior to the expiry of the time limit for offers submission, by submitting questions in writing to the Procurement Dpt.

1. All offered items should be brand new without defects or damages, first class and suitable for the purpose for which they are intended. The requested product codes have to be clearly stated within the offer.
2. The recycling fee (in line with the provisions of P.D. 115/2004) should be included in the offered prices.
3. Warranty period: min one (1) year.
4. Offer validity: min two(2) months .
5. Delivery Terms: a. Delivery Place: PPA S.A. Container Terminal, Neo Ikonio - Perama(DDP terms), b. Delivery Time: max fifteen (15) working days from each different PPA's request and given that half of the quantity will be delivered to PPA upon the official award, while the other half after up to (6) months from the official award upon request from PPA''. Candidates shall indicate the items' delivery time within their technical offer.

6. Payment Terms: within two (2) months upon invoicing and following relevant procedures of delivery (on behalf of Supplier) and acceptance (on behalf of PPA).
